

Keynote Speaker **PARK DIETZ** Senior M.D., M.P.H., PH.D.

Dr. Dietz is an internationally prominent forensic psychiatrist whose pioneering research on threat assessment and stalking and service to the FBI's former Behavioral Science Unit led to his creation of Threat Assessment Group, Inc. (www.taginc.com), the world's first company devoted to workplace violence prevention, headquartered in Newport Beach, California. For over 30 years, TAG has been helping corporations deal with their most challenging cases and has been educating corporate America on the management of troubled employees, troubling situations, and behavioral risks in the workplace, with a focus on crisis prevention. In September 2017, TAG is launching 17 state-of-the-art and customizable e-learning programs for corporate audiences.

Dr. Dietz was named one of the "Top 25 Most Influential People in the Security Industry" by Security magazine. In 2014, Biography.com listed Dr. Dietz among the 10 most famous psychiatrists in history. He is best known to the public as a government expert in notorious criminal cases, including Dylann Roof, the Columbine killers, and more than a dozen other mass murderers,; Dzhokhar Tsarnaev (Boston Marathon Bombing) the Unabomber, and other bombers; the assassination attempts on President Reagan and on Congresswoman Gabrielle Giffords; Jeffrey Dahmer and more than 25 other serial killers; and many others.

Dr. Dietz is a Past President of the American Academy of Psychiatry and the Law, a Distinguished Life Fellow of the American Psychiatric Association, and a Fellow of the American Academy of Forensic Sciences. He has been a forensic psychiatrist for the FBI's Behavioral Science Unit and Behavioral Analysis Units and for the New York State Police Forensic Sciences Unit and has consulted to the CIA, U.S. Secret Service, DOJ, DEA, U.S. Marshall's Service, IRS, and International War Crimes Tribunal. He has authored more than 100 publications.

Educated at Cornell and Johns Hopkins, Dr. Dietz simultaneously earned an M.D., a master's degree in public health, and a Ph.D. in sociology. He trained in psychiatry at the Johns Hopkins Hospital and in forensic psychiatry at the University of Pennsylvania. He served as an Assistant Professor of Psychiatry at the Harvard Medical School and as Professor of Law and Professor of Behavioral Medicine and Psychiatry at the University of Virginia. He is now Clinical Professor of Psychiatry and Biobehavioral Sciences at the UCLA David Geffen School of Medicine. He has also been a Visiting Professor of Psychiatry at the University of California, Irvine.
